

## CLAIM YOUR FOOTMUFF PROMOTION (“PROMOTION”) TERMS AND CONDITIONS

### THE PROMOTER

### PROMOTION PERIOD

### ELIGIBILITY

## CLAIMS

Within three (3) working days of Claiming Participants will be sent an email to confirm whether their Claim has been successful and validated. Please note that Claims received will be processed within 3 working days from the date of notification.

- 11.If a Claim is deemed to have been submitted incorrectly, the Participant will be notified via email and offered the opportunity to provide the required information within seven (7) days. If no response is received within seven (7) days of the email, then the Claim shall be marked as invalid and the Participant will no longer be eligible to receive the Reward.
- 12.Free of charge delivery of the Reward will be to the United Kingdom, Channel Islands, Isle of Man, Northern Ireland or Republic of Ireland postal addresses provided in the Claim.

## **GENERAL**
